## PRIVACY STATEMENT

- 6. For the purpose of credit reporting, we will exchange the information about of customers with the reputable reference sources and clearing house services.
- 7. We will not use or share internally or externally the personally identifiable medical information for any purpose other than underwriting or administration of a customer's or to which the customer consents.
- 8. We will attempt to keep customer files complete. Up to date and accurate. We will inform customers how and where to conveniently access their account information (except when we are prohibited by law), and how to notify us about errors which we will promptly correct.
- 9. We will continuously assess ourselves to ensure that customer privacy is respected.

### **B.** Internet and Website Privacy
